Aims &

Objectives: To develop key skills through the experience of work.

To gain an insight into working as a beauty therapist and /or hairdresser.

Key Tasks: Students will follow the Hairdressing & Beauty Therapy course timetable at the Guernsey College of

Further Education which includes beauty therapy theory & practise as well as IT, Anatomy &

Physiology, Reception and Communication Skills.

After a certain amount of observation, training and under supervision students may do simple tasks in the salon such as basic beauty treatments and reception duties. Students may also sample the various types of beauty treatments available which include facials, eyelash tinting, manicures, pedicures, massages, electrolysis and waxing. The hair salon covers cutting, washing, colouring,

perming and various hair treatments.

Requirements: A genuine interest in hairdressing and / or beauty therapy.

Friendly, caring and considerate nature.

Students wishing to study Hair & Beauty Therapy at the College of FE when they leave school will require 3 GCSEs at C and above for the NVQ qualification. Alternative courses may be available for

those not achieving GCSEs.

Clothing: Students must wear black trousers and a white top, a tabard will be provided and must wear

closed in shoes. No piercings or tattoos must be visible (other than ear studs). Hair to be worn tied

back.

Working Hours: 9am 5pm Monday to Friday with flexible finish times (sometimes earlier).
