Objectives: To gain an insight into the work of a dental laboratory.

Key Tasks: Students will observe/shadow the dental technicians to gain an overview of their duties. After

training and under supervision students may assist with basic tasks which may include answering the telephone, making appointments, filing, talking and interacting with the patients, work shadowing the dental technician's work. Some hands on work is possible such as preparing dental

models for false teeth, making sports guards, watching how braces are made etc.
